

COFFEYVILLE CHRISTMAS CASH GIVEAWAY 2008
Contest Rules

- 1) Must be 18 years old as of November 16, 2008 to participate in the contest.
- 2) For every \$10 in merchandise purchased or commission paid for service industries, the individual will receive one (1) ticket.
- 3) The contest will run from 12 p.m. on Sunday, November 16, 2008 through 8:00 a.m. on Friday, December 19, 2008.
- 4) \$1000 in Christmas Bucks will be given away on Friday, December 5, 2008 at 5:00 p.m. at the Coffeyville Chamber of Commerce and Posted on the Santa Float in the Coffeyville Christmas Parade that evening. Tickets received for purchases made between Noon Sunday, November 16, 2008 and 8 a.m. Friday, December 5, 2008, will be eligible for this drawing. **You need not be present to win. But, if you are present at the Christmas Parade and you hold the winning ticket that is posted on the Santa Float and you present the winning ticket to the Coffeyville Area Chamber of Commerce building, located at 807 Walnut, before 9:00 pm on Friday December 5, 2008 you could win a bonus of \$1000. That's a total of \$2000. After 9:00p.m. Friday December 5, 2008 the winning amount will only be \$1000.** After the Christmas Parade, the winning number will be announced on local radio stations KGGF, printed in the Sunday edition of the Coffeyville Journal and posted on www.coffeyvillechamber.org. If after five (5) days, (4 p.m. Wednesday December 10, 2008) no one comes forward with the corresponding ticket, the process will be repeated until a winning ticket is presented. The winning ticket will need to be presented at the Coffeyville Area Chamber of Commerce. After the winning ticket is verified, the participant will be awarded Christmas Bucks for the total prize amount. [NOTE: Do not throw tickets away after the initial drawing. The winning ticket for the second drawing will be drawn from tickets collected between November 16 and December 12, 2008 and so forth].
- 5) Two (2) drawings for \$1,000 in Christmas Bucks will be given away on Friday, December 12, 2008 at 5:00 p.m. Tickets received for purchases made between Noon Sunday, November 16, 2008 and 8 a.m. Friday, December 12, 2008 will be eligible for this drawing. **You need not be present to win.** The winning number will be announced on local radio stations KGGF, printed in the Sunday edition of the Coffeyville Journal and posted on www.coffeyvillechamber.org. If after five (5) days, (4 p.m. Wednesday, December 17, 2008) no one comes forward with the corresponding ticket, the process will be repeated until a winning ticket is presented. The winning ticket will need to be presented at the Coffeyville Area Chamber of Commerce, located at 807 Walnut. After the winning ticket is verified, the participant will be awarded Christmas Bucks for the total prize amount. [NOTE: **If there was no winner of the Bonus Bucks on the night of the Christmas Parade on December 5, 2008 a second drawing for \$1000 will take place on December 12, 2008.**]
- 6) Three (3) drawings for \$1,000 in Christmas Bucks will be given away on Friday, December 19, 2008 at 5:00 p.m. Tickets received for purchases made between Noon Sunday, November 16, 2008 and 8 a.m. Friday, December 19, 2008 will be eligible for this drawing. **You need not be present to win.** The winning number will be announced on local radio stations KGGF, printed in the Sunday edition of the Coffeyville Journal and posted on www.coffeyvillechamber.org. If after five (5) days, (4 p.m. Wednesday, December 24, 2008) no one comes forward with the corresponding ticket, the process will be repeated until a winning ticket is presented. The winning ticket will need to be presented at the Coffeyville Area Chamber of Commerce, located at 807 Walnut. After the winning ticket is verified, the participant will be awarded Christmas Bucks for the total prize amount.

7) Ticket Drawing Process

Reminder: The goal of this program is to encourage community citizens to shop locally, as well as, local businesses doing business with each other. All Merchants have the same initial investment of \$100 in the Christmas Cash Giveaway 2008 Program. This Ticket Drawing Process will ensure that all Merchants have an equal chance that a winner may be drawn from their business.

Tickets will be gathered from each participating Merchant on Friday each week (more often for large volume Merchants). Tickets will be stored at the Chamber Office in separate containers for each Merchant. Drawings will take place on Fridays at 5:00 p.m. at the Chamber Office.

A single ticket will be pulled from each Merchants container and placed in a drawing pot. All tickets will be marked with a corresponding number written on the back of each ticket. The number on the back will ensure proper return of tickets to the corresponding Merchants container when that weeks drawing is complete. A final drawing will take place from the drawing pot. That will be the winning ticket for that drawing. Each drawing will be done in this manner.

8) Christmas Bucks will be redeemable as cash at the participating merchants of the 2008 Christmas Cash Give Away. Merchants may receive them as cash and then bring them to the Coffeyville Area Chamber of Commerce, located at 807 Walnut to be fully reimbursed. You must be one of the participating merchants to redeem Christmas Bucks.

9) Owners, employees and relatives of the owners and employees of participating merchants are eligible to win, provided the winning ticket did not come from those tickets issued to that merchant.

10) No purchase is necessary to participate in the contest. Participating businesses will issue one (1) free ticket per week per person. The free ticket must be requested and the individual requesting it will be required to sign for the ticket.

11) By entering the Contest, you agree and accept that the Coffeyville Chamber of Commerce and City of Coffeyville may be required to file certain information with various governmental agencies with respect to the prizes exceeding certain amounts, and, in such event, a participant that wins any such prize must complete any written materials that may be required by any such governmental agencies and will be requested to do so by the Coffeyville Area Chamber of Commerce and City of Coffeyville.
